#### **COMMISSION REPORTS**

Commissioner Mullen reported that he attended the RMDC board meeting on Thursday. Jeri Lee Wilkenson is leaving as director of Area IV Agency on Aging, after filling in for the past year. The auditors came to give their report; there were no negative findings. They discussed a couple programs that they are running - Foster Grandparent and Senior Companion, and reviewed the Head Start policies.

Commissioner Kirsch reported on the Clancy Water and Sewer meeting held on Tuesday night. They got the water testing results back and are getting the results put into report form. The district was approved for both grants, from DNRC and TSEP. They discussed the 2020 census and how it might help the district. They are still having trouble getting the income surveys back.
