## **RESOLUTION 24-2022**

## RESOLUTION ADOPTING REVISED FEE SCHEDULE FOR JEFFERSON COUNTY PLANNING DEPARTMENT

**WHEREAS,** Mont. Code Ann. §§ 76-2-101 *et. seq.*, 76-3-601 *et seq.*, and 76-8-101 *et seq.* authorize the governing body to adopt fees for local review of applications and land use matters in the areas of zoning, subdivision review, and buildings for lease or rent, respectively; and,

WHEREAS, while Jefferson County has adopted fees in certain areas of local land use review, following a periodic review of the fees charged, the Jefferson County Commission finds the fees charged in the current fee structure are not commensurate with the costs of review; and,

**WHEREAS**, the Jefferson County Planner has prepared a revised Jefferson County Planning Department Fee Schedule which the Jefferson County Commission finds more accurately reflects reasonable fees commensurate with the costs of review.

**ACCORDINGLY, IT IS RESOLVED,** the Jefferson County Planning Department Fee Schedule attached as Exhibit 1, and incorporated by reference, is hereby adopted, effective October 1, 2022.

**IT IS FURTHER RESOLVED,** any fees or fee schedule previously adopted by Jefferson County and related to local review of applications and land use matters in the areas of zoning, subdivision review, and buildings for lease or rent, are hereby superceded by this Resolution No. 24-2022.

IT IS FURTHER RESOLVED, within 1 year of the date of the passage of this Resolution the Jefferson County Commission shall conduct a review of the revised Jefferson County Planning Department Fee Schedule to assess whether the fee structure is commensurate with the costs of review.


